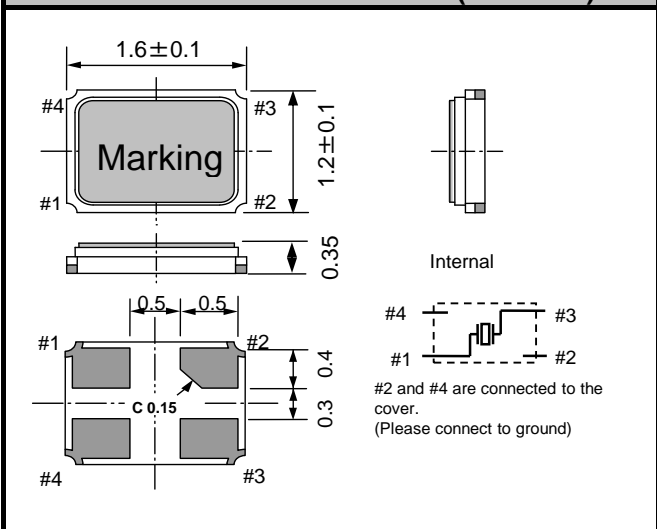

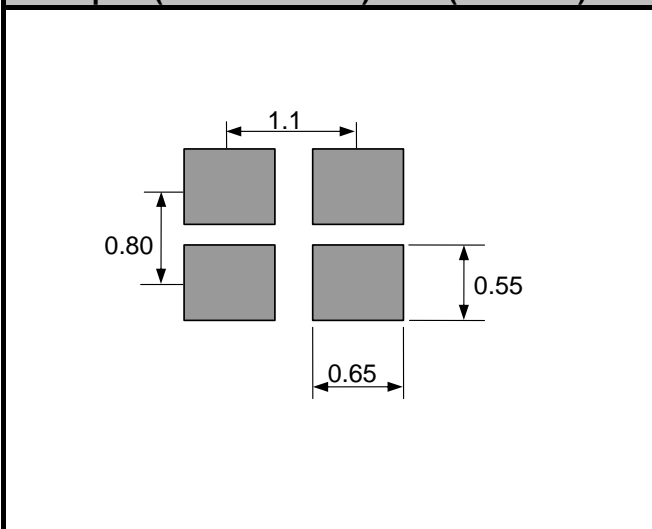

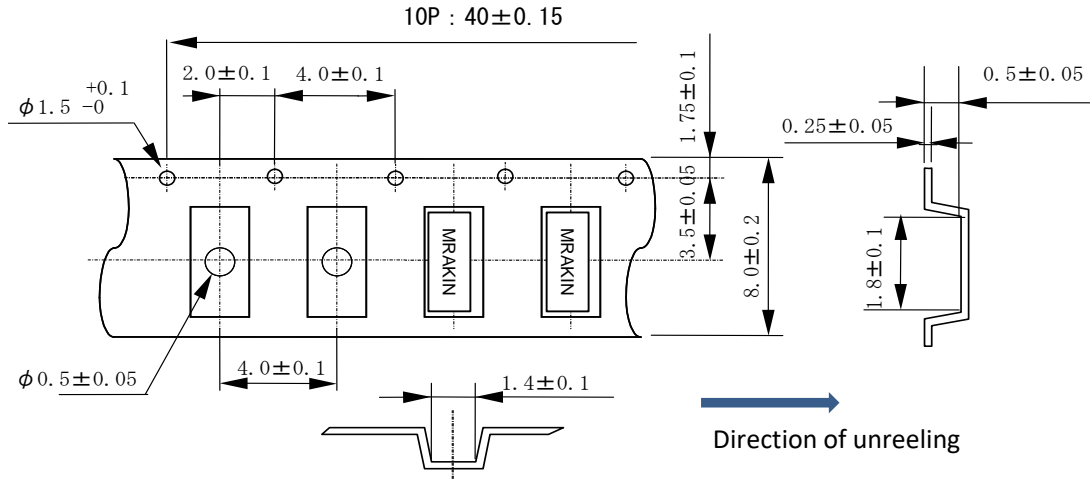

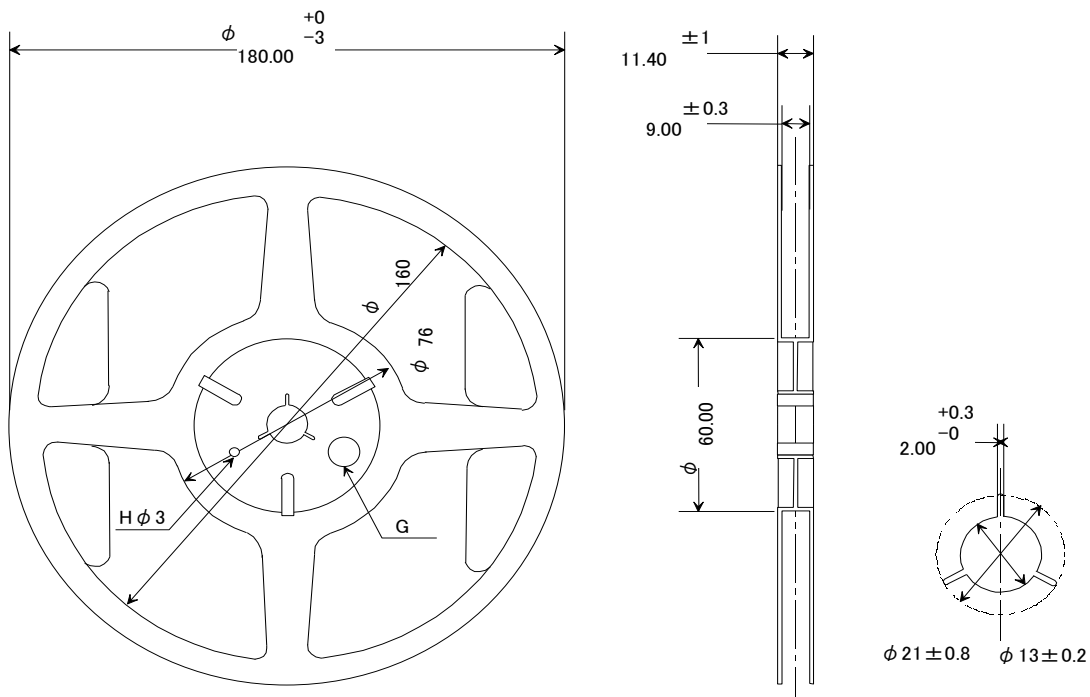


(2) Reel dimensions

Center material : PS

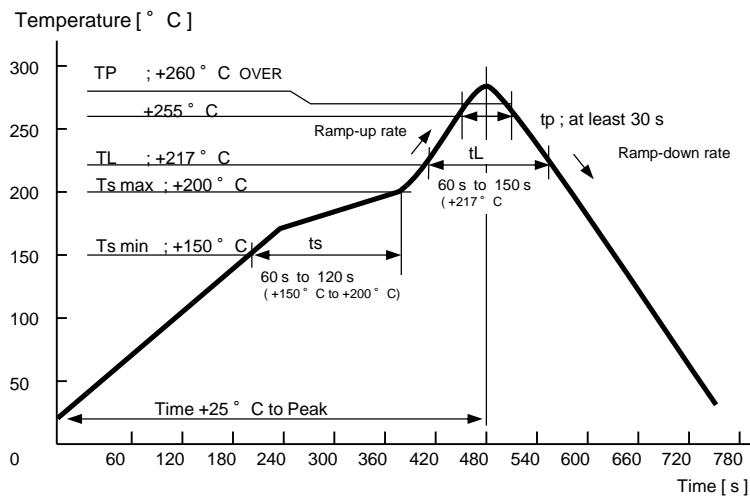
